

# **2024 Primary and General Election Update**



With the Presidential Nomination Primary complete, the 2024 Primary and General elections are scheduled for later this year.

The Primary Election is Tuesday, Aug. 13; and the General Election is Tuesday, Nov. 5.

#### **Municipal Election**

Crystal will have four council seats on the 2024 general election ballot. The term for mayor and three council seats representing Ward 3 and Ward 4 in northern Crystal, and Section I (Wards 1 and 2) in southern Crystal, expire at the end of 2024.

#### **Election Judges Needed**

Election judges play an important role in administering elections. Serving as an election judge is a great opportunity to learn about the election process while serving your community.

#### **Candidate Filings**

The council member filing period is open from May 21 – June 4. All candidates must be an eligible voter, at least 21 years of age when assuming office, a resident of their ward or section at the time of filing for office, and have no other affidavit on file for any office.

The city council reviews service demands, the costs to meet those demands, and prioritizes them in a biennial budget cycle.

On Dec. 5, 2023, the council adopted its revised 2023-2024 budget that provides a balanced budget while meeting the service demands of the community and legislative mandates and provides a sound financial plan that is responsive to the financial concerns of Crystal taxpayers.

The budget reflects a 10% increase in the property tax levy from 2023. This increase ensures the city can provide core services and invest in the capital needs for aging community infrastructure.

The 2024 budget was the second year of the city's second biennial budget. Looking forward two years allows a first-year focus on operations and a second-year focus on long-term planning/capital.

Priorities for 2024 include:

- Meet service demands of the community and legislative mandates while striving for minimal impact to taxpayers.
- Monitor economic challenges.
- Provide sound financial planning for a two-year budget that ensures continued core services.
- Continue to fund future capital needs including parks and street improvements.
- Provide competitive wages and benefits to retain quality people to provide effective and efficient services to residents and businesses.

### Organics Recycling Charges Are a State Requirement

And Haulers Must Charge All Equally



Under Hennepin County Recycling Ordinance 13, all cities must require garbage haulers to offer curbside organic/food waste recycling or conduct organized curbside organics collection. Furthermore, according to state law, garbage haulers that have an additional charge for organics recycling must charge all its customers the same, whether or not that customer participates in organics recycling.

Local governments cannot opt out of the state requirement that haulers charge all customers for organics recycling equally, nor do cities control the amount haulers can charge.

With the weather warming, the West Metro Fire-Rescue District reminds residents about local recreational fires rules. Please, also, use common courtesy while adhering to these following rules:

- 1. Use only aged, dry firewood. Do not burn yard waste, construction materials or household trash.
- 2. Use approved outdoor fireplaces or pits, at grade or below, no more than 3 ft. in diameter. Ring with brick, rock, or other non-combustible material. Purchased fire pits must be 3 ft. in diameter or smaller.
- 3. Fire pits shall be at least 25 ft. from any structure or combustible materials. Portable fire pits shall be 15 ft. from any structure or combustible materials.
- 5. Recreational fires are not allowed when winds exceed 7 miles per hour.
- 6. Fires shall be constantly attended by the property owner or designated adult until it is completely extinguished. A garden hose or other emergency extinguishment must be within 15 feet of the fire.
- 7. Recreational fires may be prohibited by action of the Minnesota DNR.
- 8. All recreational fires shall be extinguished no later than 11 p.m.
- 9. Property owners are liable for any or all damages from having a recreational fire.
- 10. Fires shall be immediately extinguished at the discretion of the fire official for not complying with city ordinances which may result in a citation.



# **Creating a Separate Lot**


Several years ago, the city reduced its minimum lot width from 60 to 50 ft. and its minimum lot area from 7,500 to 6,000 sq. ft.

### Blue Line Extension Update




Metro Transit and Hennepin County are planning to extend light rail transit (the Blue Line) from Minneapolis to Brooklyn Park. In Crystal, the line would run in the median of Bottineau Blvd. with a station at Bass Lake Road.

The environmental review is underway and the city council will vote on municipal consent in early fall 2024. Construction is anticipated in 2027-29.

### UTILITY RECONSTRUCTION

Utility reconstruction will start this spring and include the replacement of sanitary sewer (including a portion of the connected services to the properties), water main (including the water services to the curb stops at each property), storm sewer as needed, and a new sidewalk along the east side of the roadway.

Once complete, the curb and gutter will be replaced and the streets paved.

The project is a joint operation with the City of New Hope.

In all, the 2024 Utility Project includes the following streets:

- Louisiana Ave. N. from Medicine Lake Rd. to 32nd Ave. N.
- 31st Ave. N. from Louisiana Ave. N. to the cul-de-sac (City of New Hope).



# **Crystal Sewer and Water Rates in 2024**

Adopting a more proactive approach with a focus on planning and coordination, the City of Crystal has a longterm plan for infrastructure including funding for all utilityrelated capital projects.

For a detailed description of each utility bill line item, frequently asked questions and other information, visit <u>go.crystalmn.gov/rates</u> or link using the QR code.



In general, the fixed water and sewer

fee structure covers the cost of operating and maintaining the infrastructure associated with providing water (water meters, etc.) and sanitary sewer service. The consumption portion goes toward providing the actual water and treatment of waste water. The storm drainage fee is associated with storm water infrastructure throughout the city (catch basins, pipes, ponds, infiltration areas, etc.) as part of overall storm water management.

How does Crystal's utility bills compare to neighboring cities? Unfortunately, this is not a straight forward question. Cities use a number of funding methods to maintain, operate and replace infrastructure, including property taxes, utility (water, sanitary sewer, stormwater) fees, franchise fees, special assessments, State Aid Funds (gas tax) and bonding (loans).

The city council desires transparency with how infrastructure projects are funded; therefore, the city only uses property taxes, utility fees and State Aid Funds for infrastructure maintenance and replacement, and not other funding sources used by many neighboring cities.

# Adopt-a-Storm Drain in 2024

Residents who participate in the City of Crystal Adopt-a-Storm Drain program adopt a storm drain in their neighborhood and keep it clear of leaves, trash, and other debris to reduce pollution.

Storm drains flow directly to local lakes, rivers and wetlands, acting as a conduit for pollutants.

In 2023, 11 participants collected more than 165 lbs. of debris from storm drains in Crystal.

# Crystal Bulky Waste Curbside Cleanup April 1 – 11

If it's time to get rid of unusable furniture, mattresses, carpet, appliances and more, the Hennepin Recycling Group (HRG) curbside bulky waste cleanup is April 1 – 11.

Crystal is divided into different zones, each with its own day of collection. Find your date and get more information at **bit.ly/HRGbulky**.

Place materials at the curb by 7 a.m. on your designated day. Reminder postcards are sent in March with collection dates and details regarding acceptable items. TVs, other electronics, tires, paint and chemicals are not accepted.

The cost of the bulky waste curbside cleanup program has more than doubled in the past five years. To reduce costs, the HRG set limits on the amount of material collected. Minor changes include:

- General junk and household building materials amount is limited to one level truck bed (generally 4 ft. x 8 ft. x 2 ft.).
- Unusable furniture: Limit two.
- Mattresses or box springs: Limit two.
- Appliances: Limit two.

Items exceeding limits will be left behind by the hauler. Residents will need to arrange and pay for separate disposal.

# Maintaining Your Lawn

Lawns in Crystal cannot exceed 8 inches in height. If a lawn violation is reported, the city will check the property. If there is a violation, the city will post a 10-day written notice. If the lawn remains in violation after 10 days, the city will have its contractor cut the lawn and bill the property owner. Unpaid bills will be assessed against the property.




**NO MOW MAY** "No Mow May" is the practice of minimizing lawn cutting during May

when dandelions, clover, etc. provide forage for pollinators early in the season before other flowering plants bloom. To accommodate Crystal residents practicing No Mow May, the city will delay long grass enforcement until June 1.

It is unlawful to throw, spill, or leave dirt, garbage, sweepings, compost, grass clippings, leaves, or brush in any street, alley, sidewalk, park or other public place in the city. When these items end up in the street or alley, they wash into our streams, wetlands and lakes and degrade water quality.

It is a violation of city code to allow your lawn to be worn down to dirt or mud which often occurs when vehicles are parked on or driven over lawns. Motor vehicles may not be parked or driven on grass or other landscape




#### **REFUSE/LITTER**

Keep properties free of litter. In addition to household garbage, appliances, furniture and miscellaneous junk, litter also refers to motor vehicles, trailers, recreational vehicles and equipment that are inoperable, unlicensed, partially dismantled or abandoned.

Household garbage must be stored in an approved garbage container and collected by a licensed hauler. Other litter must be stored in a building such as a garage or storage shed. Do your part to be a good neighbor.

Spring cleaning may leave you with a pile of stuff to get rid of. Here's your chance to recycle those items that can be recycled, but can't go in your recycling cart.

Drop off your mattresses, electronics, appliances, tires, scrap metal, bikes, batteries and more at Brooklyn Park's Operations & Maintenance facility, 8300 Noble Ave. N. on Saturday, April 27 from 8 a.m. to 3 p.m. Fees may be charged for some items. There will also be free paper shredding.

Help yourself, your wallet and the planet by purchasing a rain barrel and/or a compost bin at a reduced price through the Recycling Association of Minnesota (RAM).

Food scraps such as fruit and vegetable peels, stale bread, wilted lettuce, coffee grounds and egg shells, as well as weeds, faded flowers and vines are among things that go into compost instead of garbage. Compost can be used as yard mulch and plant food. Keeping organic waste out of the garbage reduces trash volume. Residents could switch to a smaller garbage cart and save money.

Capture rain in a rain barrel and have a free source of water for the garden. In addition to saving money, rain barrels keep moisture away from a home's foundation and prevent debris from washing into the city's storm sewers.
